Penelitian ini bertujuan untuk mengevaluasi perbandingan pengajuan dan penutupan persekot sebelum dan sesudah penerapan sistem aplikasi IPOS pada PT PLN Icon Plus. Metode penelitian ini menggunakan pendekatan studi kasus dengan mengumpulkan data dari PT PLN Icon Plus. Data diperoleh melalui wawancara, serta analisis dokumen terkait pengajuan dan penutupan persekot sebelum dan sesudah penerapan sistem aplikasi IPOS. Analisis data dilakukan melalui perbandingan statistik menggunakan uji paired samples t-test. Hasil penelitian ini menunjukkan adanya perbedaan yang signifikan antara pengajuan dan penutupan persekot sebelum dan sesudah penerapan sistem aplikasi IPOS. This study aims to evaluate the comparison of application and closure of advance employee (perseket) before and after the implementation of the IPOS application system at PT PLN Icon Plus. This research utilized a case study approach by collecting data from PT PLN Icon Plus. Data were obtained through interviews, as well as document analysis related to the application and closure of collection points before and after the implementation of the IPOS application system. Data analysis was conducted through statistical comparison using the paired samples t-test. The results of this study show significant differences between the application and closure of collection points before and after the implementation of the IPOS application system. After the implementation of IPOS, there was an improvement in efficiency, speed, and accuracy in the application and closure process of collection points. In conclusion, the implementation of the IPOS application system brings significant benefits in managing collection points at PT PLN Icon Plus. In the context of financial management, the implementation of this system can enhance efficiency, accuracy, and internal control in the application and closure of collection points.
